WELFARE AND ACCOMMODATION ARRANGEMENT FORM

TAFE SA requires international students under the age of 18 to stay with a nominated guardian approved by the Department of Home Affairs (HA) for the period that they will be under 18 while in Australia.

A nominated guardian must be the parent of the student, or a person who has custody of the student, or a relative of the student nominated by the student's custody who is 21 years or older.

A nominated guardian can hold Australian citizenship, a permanent visa, a substantive temporary visa for the duration of the student's stay or until the student turn 18. A nominated guardian can also apply for a subclass 590 visa which should be made at the same time of the student's subclass 500 visa.

A relative is defined as a parent, spouse, de facto partner, a child, brother, or sister of the applicant, step-child, step-parent, step-brother or step-sister of the applicant, grandparent, grandchild, aunt, uncle, niece or nephew, or a step-grandparent, step-grandchild, step-aunt, step-uncle, step-niece or step-nephew of the applicant.

To nominate a guardian, a completed <u>Form 157N Student Guardianship Arrangements</u> with your application to the Department of Home Affairs.
